- Financial Statements

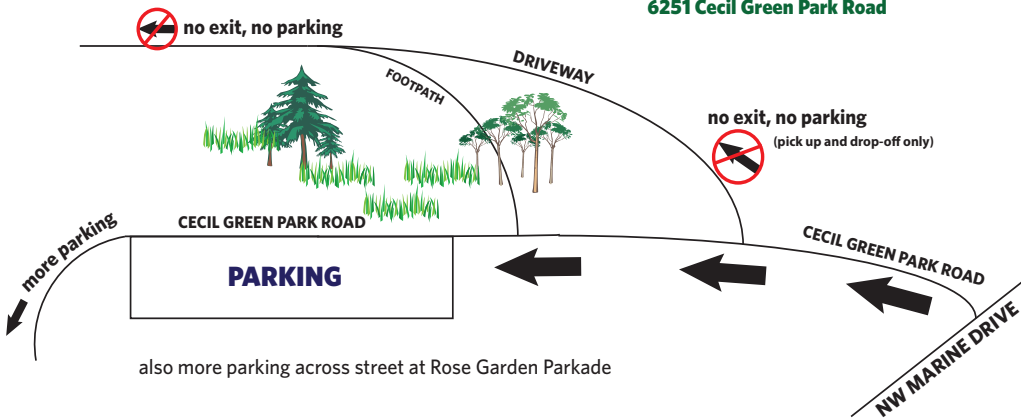
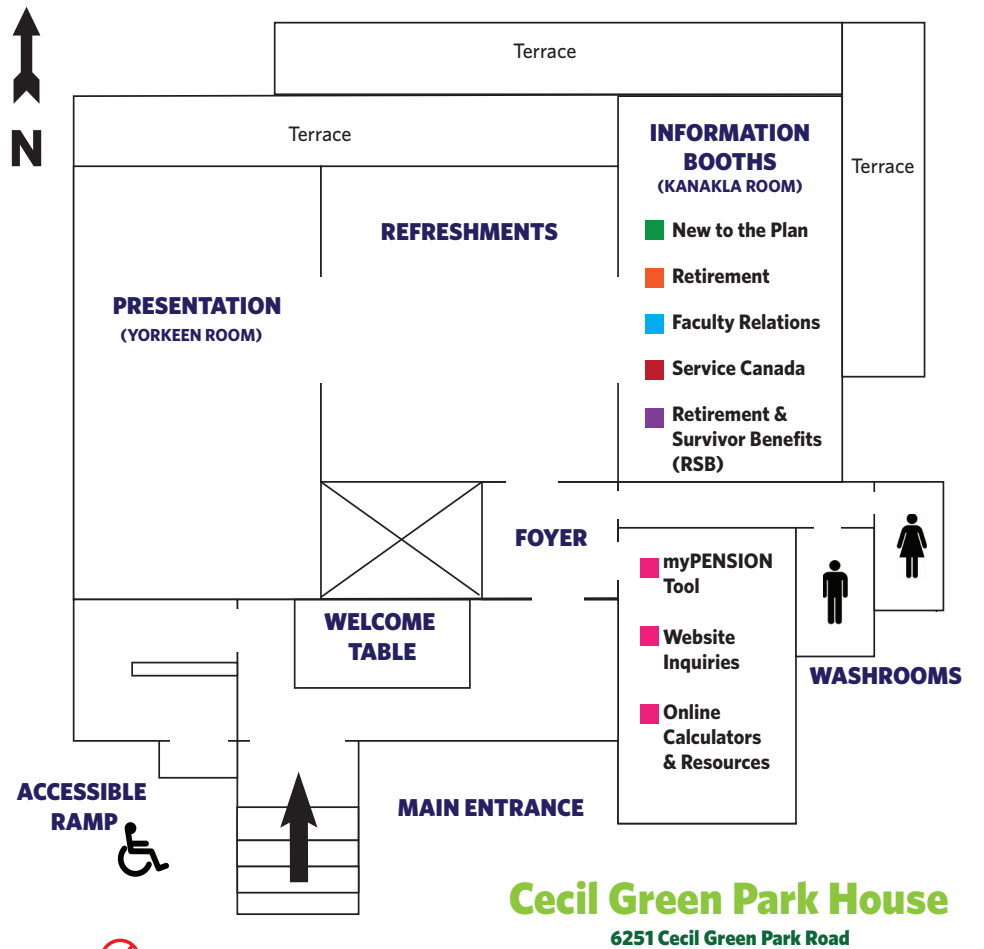
