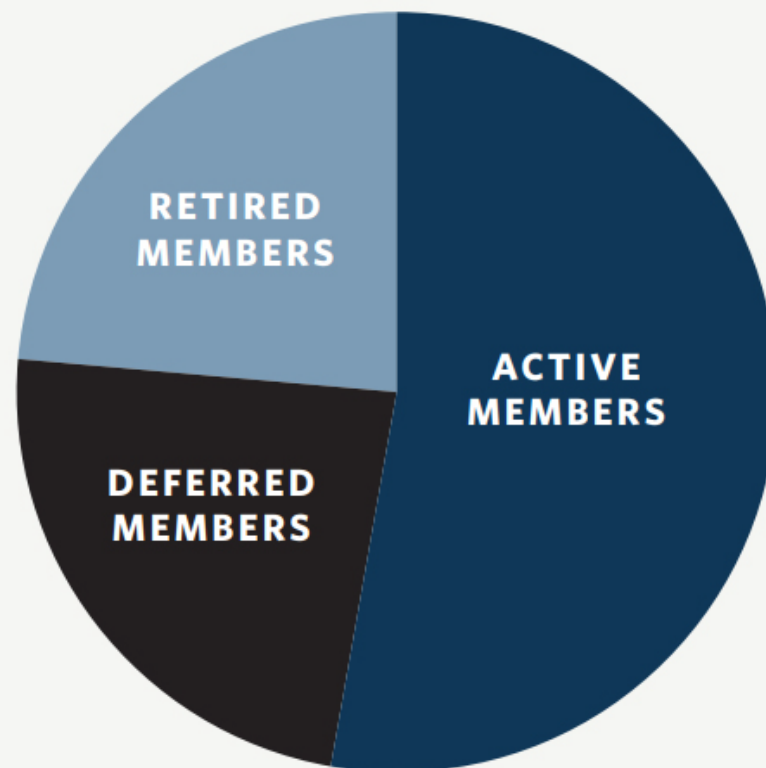

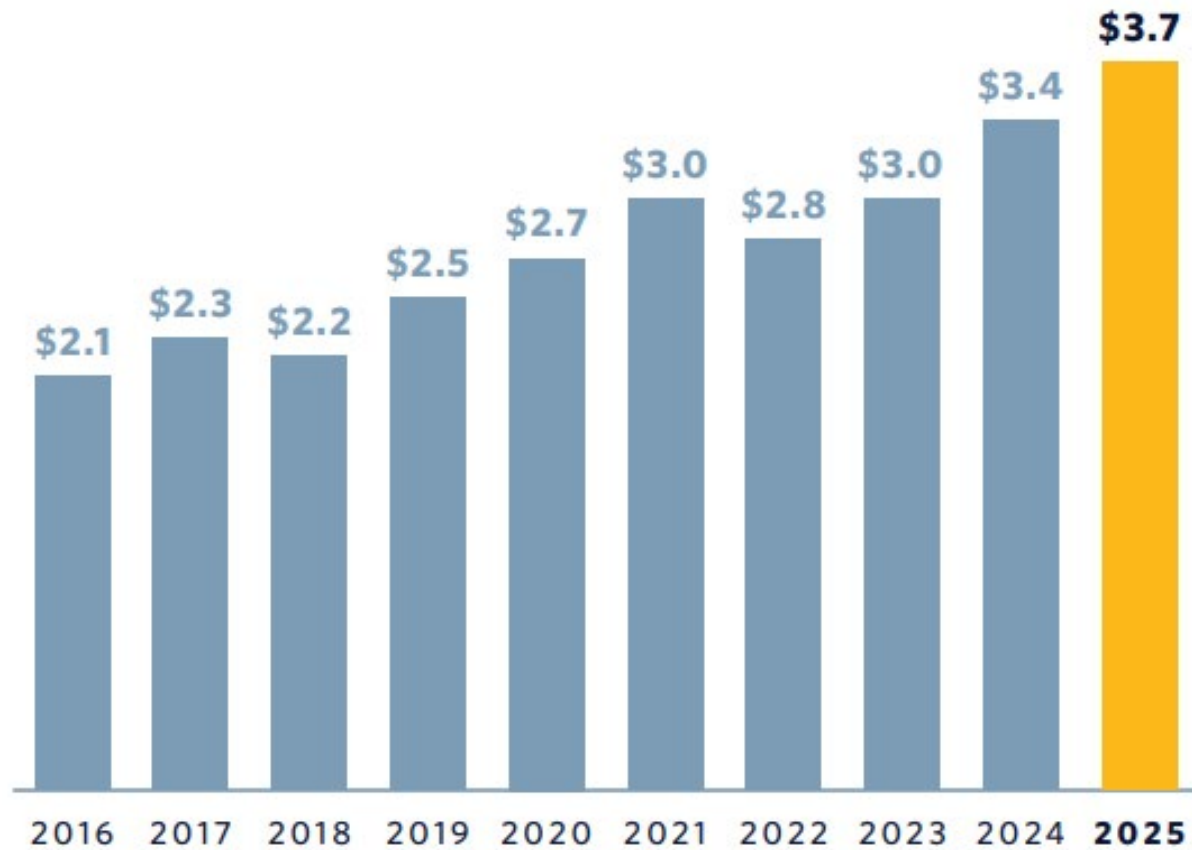

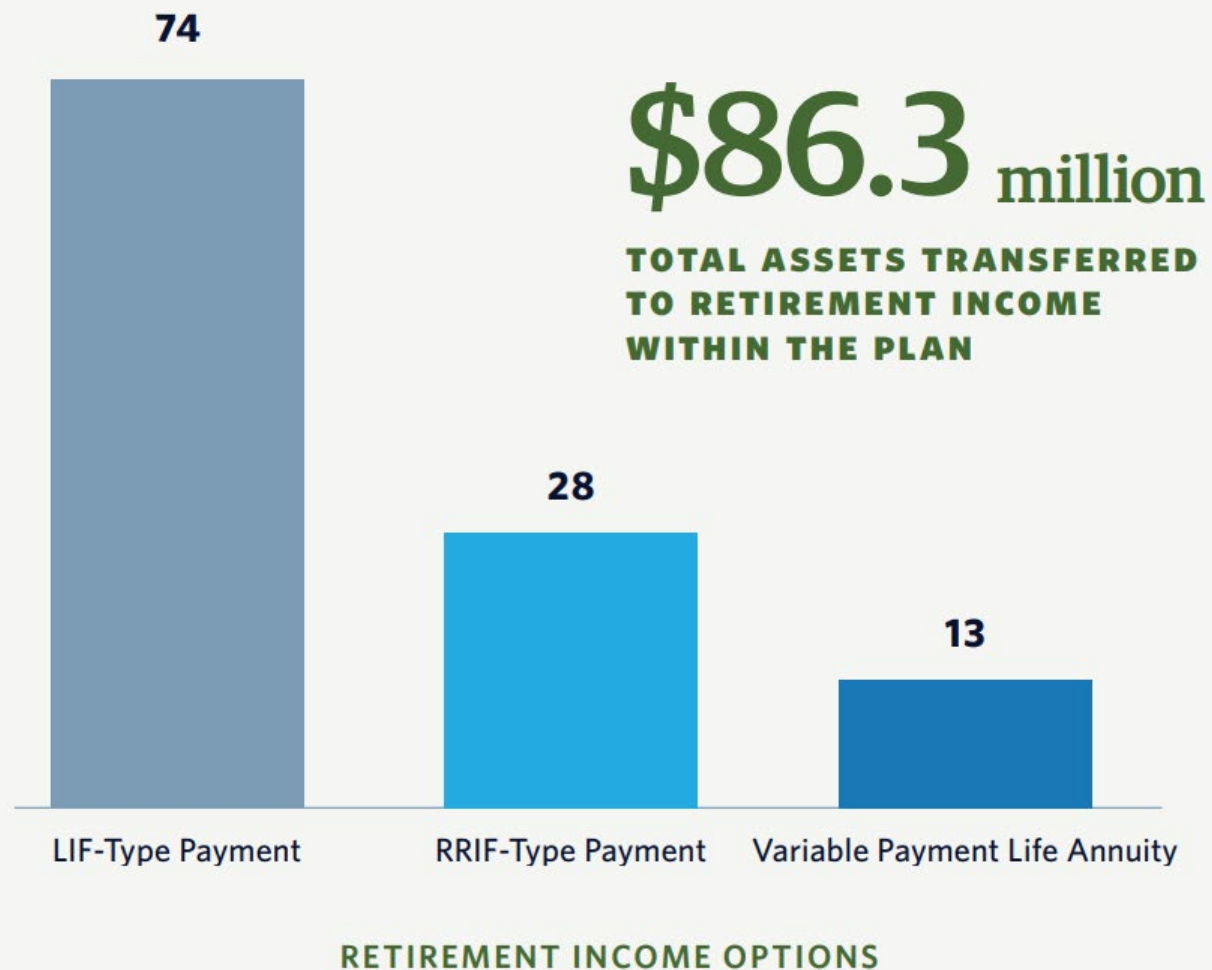
**TOTAL ASSETS OF THE

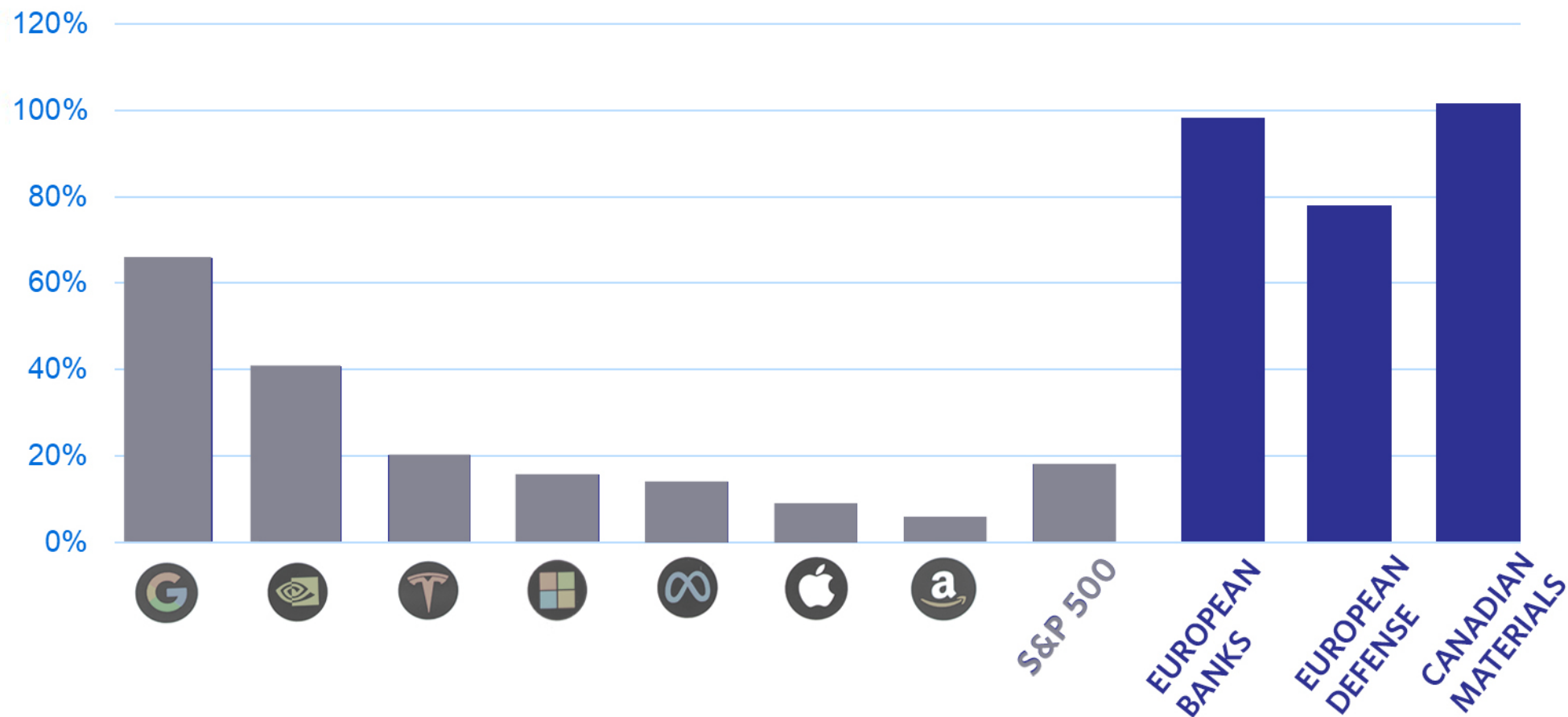

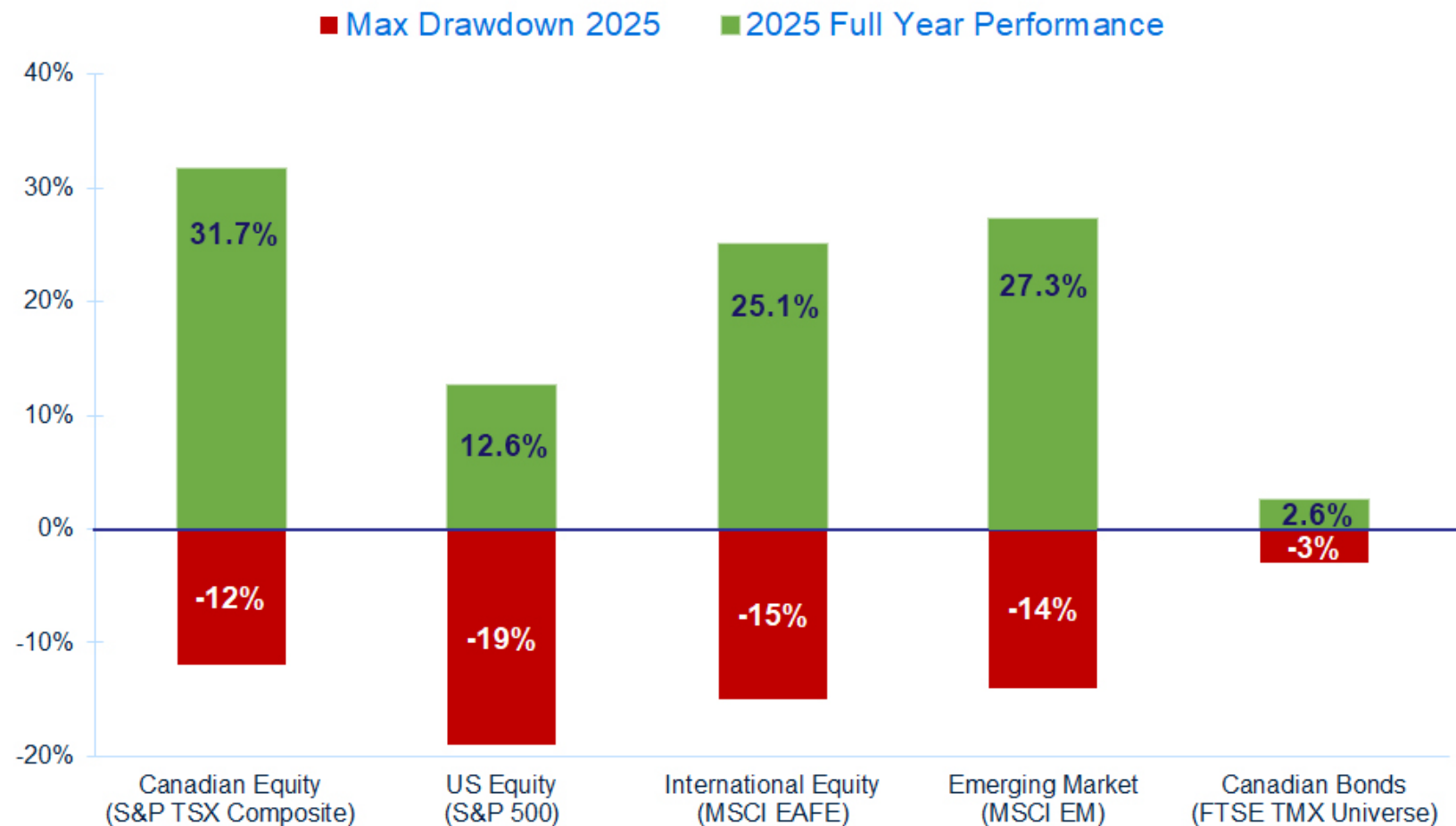

MARKET OVERVIEW

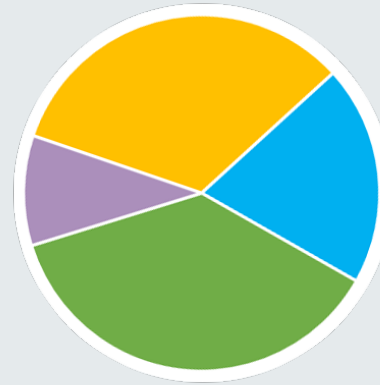

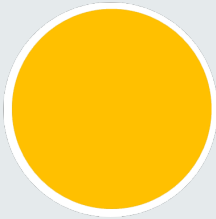

UBC FPP Balanced Fund (Default)

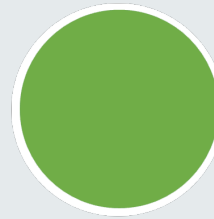

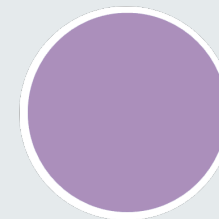
Single-Asset Class Options



UBC FPP Foreign Equity Fund

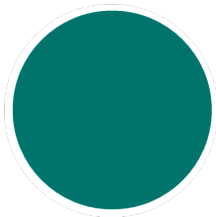


UBC FPP Bond Fund

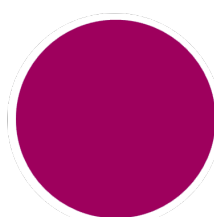

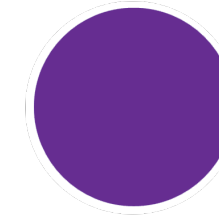

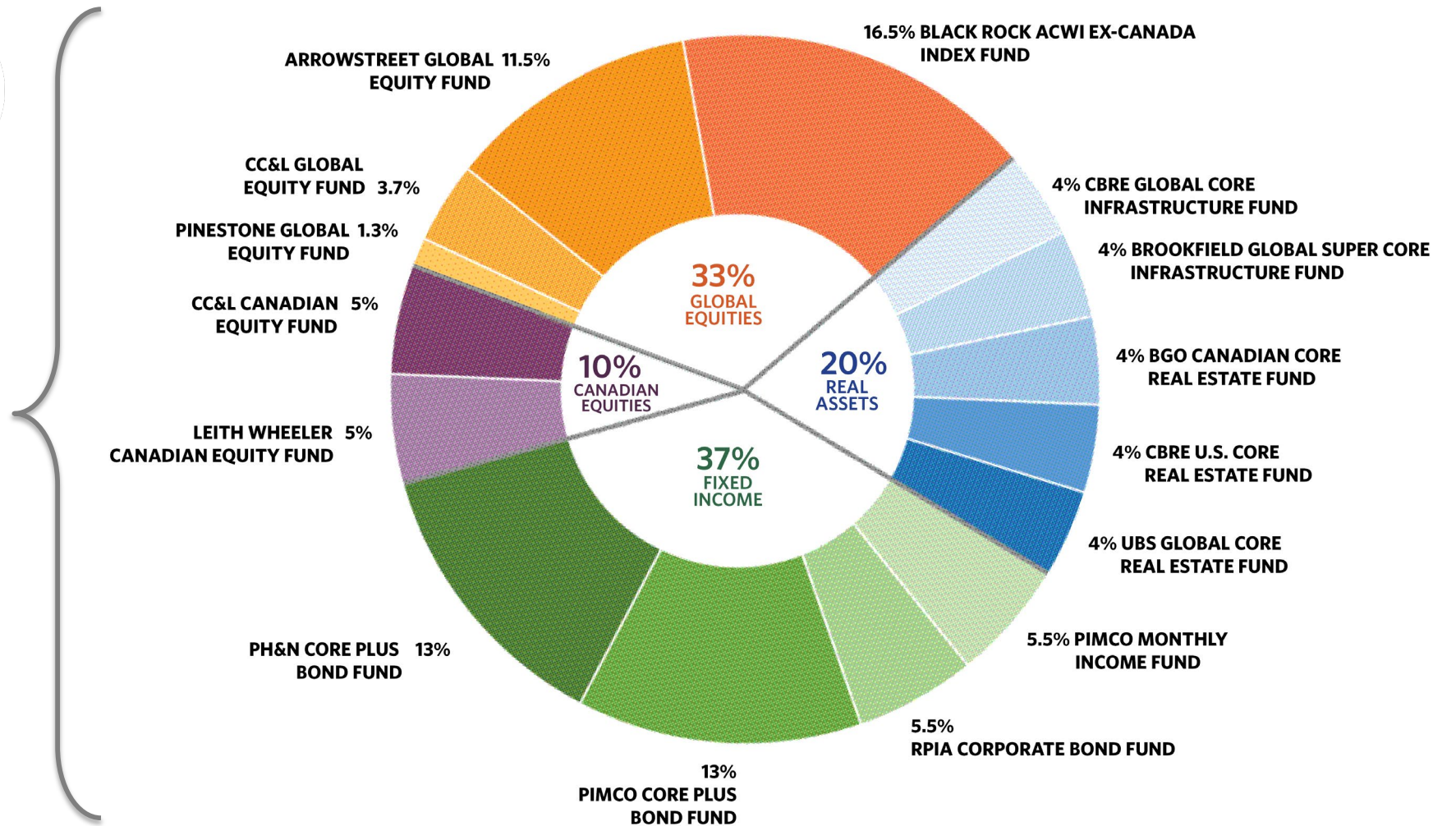

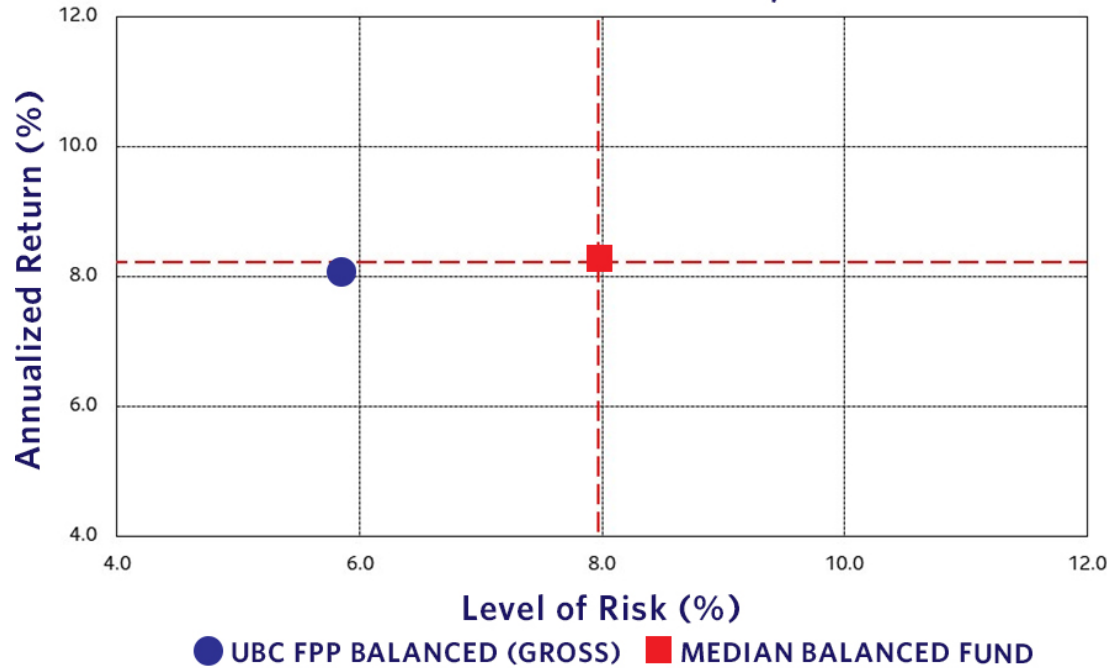

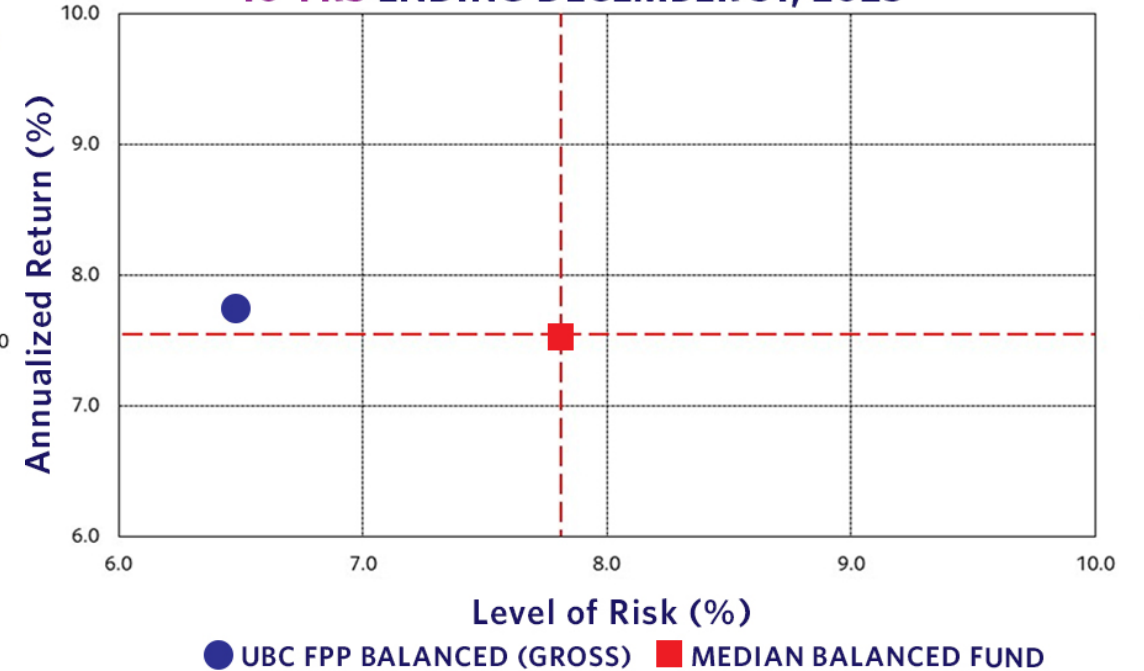
BALANCED FUND PERFORMANCE

5 YRS ENDING DECEMBER 31, 2025

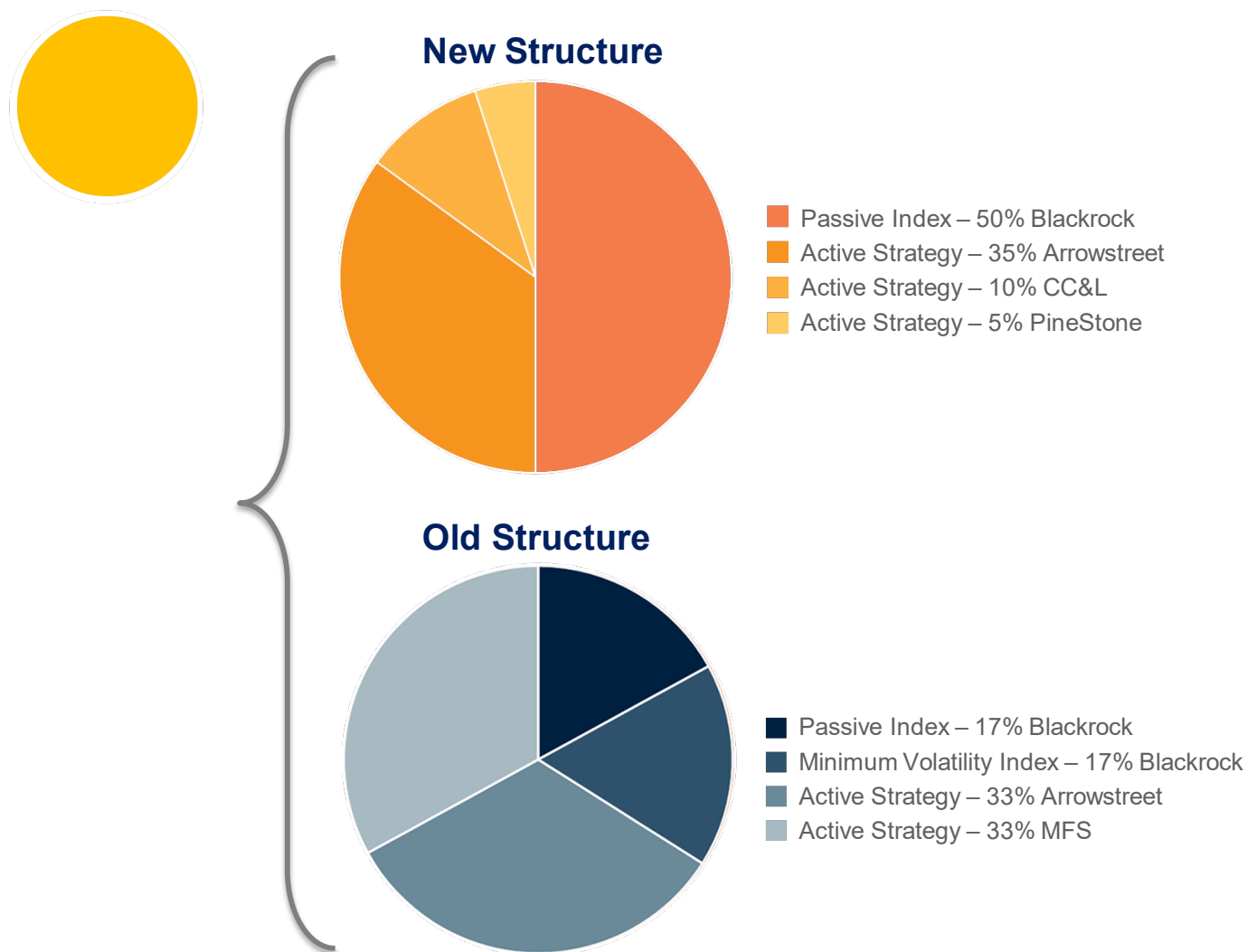


ANNUALIZED RISK/RETURN

FOREIGN EQUITY FUND UPDATE

Target Asset Mix & Level of Diversification



- Replaced two strategies (MFS; Blackrock Minimum Volatility) with two new strategies (CC&L; PineStone)

- Transition completed April 2025

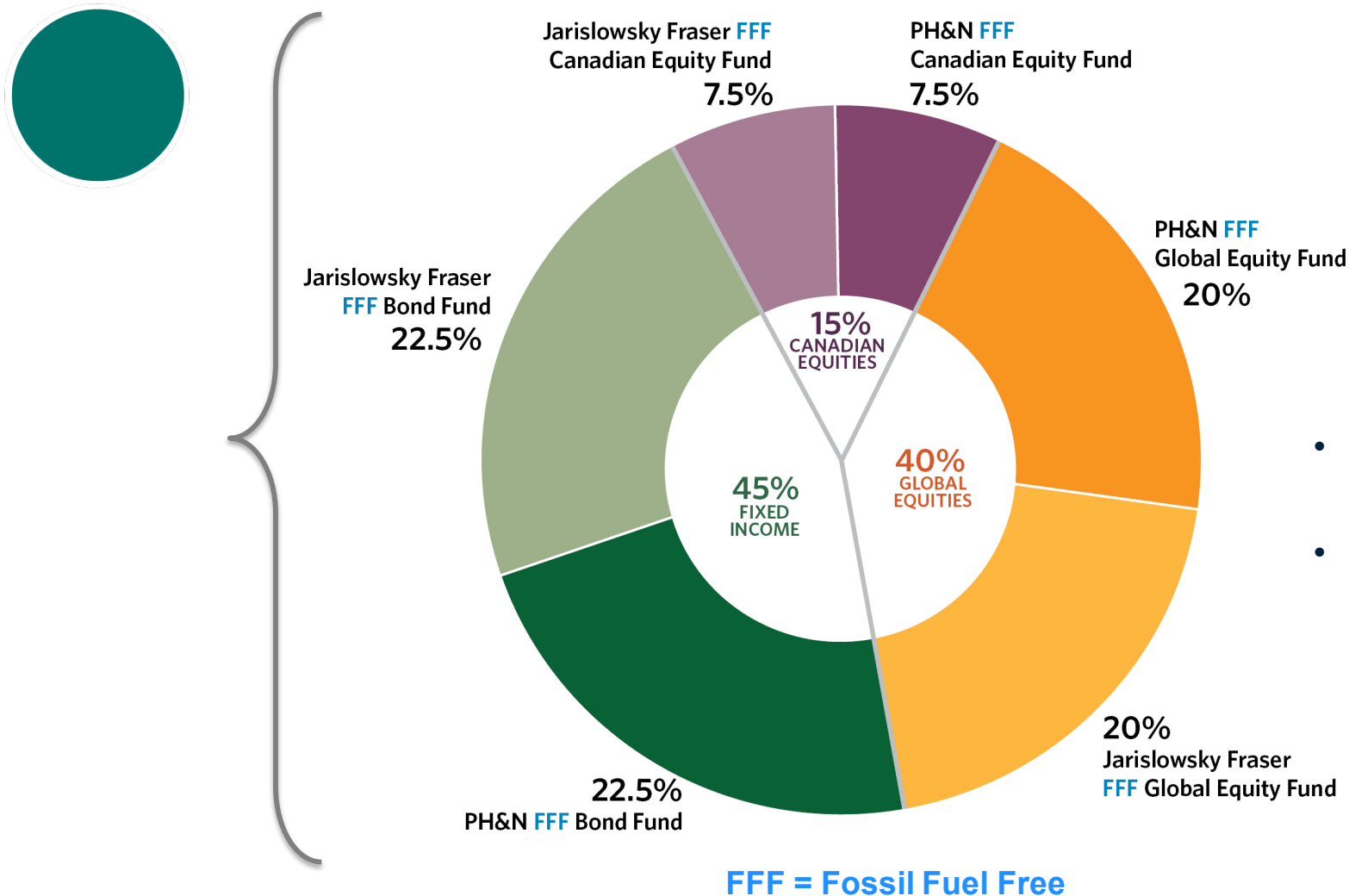
- Objective: to enhance upside while using active management for improved diversification and downside protection

- Fees reduced by ~4 basis points

INVESTMENT BELIEFS

1. Risk & Return

Higher long-term returns require higher risk in generally efficient markets

2. Active vs. Passive

Active management used selectively; not expected to consistently outperform

3. Strategic Asset Allocation

Primary determinant of long-term risk and return

4. Tactical Asset Allocation

Market timing not expected to add consistent long-term value

5. Management Structure

Separate asset-class specialist managers preferred

6. Diversification

Broad diversification required to manage risk and volatility



INVESTMENT BELIEFS

7. Investment Management

Focus on external investment managers that provide skill, alignment and value

8. Currency Hedging

Used selectively to manage overall portfolio volatility

9. Performance Evaluation

Long-term performance measured against benchmarks and peers based on 5-year evaluation period

10. Costs

All costs materially impact long-term outcomes and are tightly controlled

11. Member Flexibility

Investment choice offered to reflect individual circumstances

THE PLAN FOR 2026

- No change to investment philosophy
- Maintain broad diversification & long-term strategic asset mix
- Asset Mix Study 2026
- Ongoing review of additional fund options
- Continuous monitoring and enhancements to support strong member outcomes
